- 4. Parties/Counsel are required to hand in one physical copy of their draft order in court before the hearing commences or as soon as the matter is called to avoid court orders being endorsed after the hearing date.
- 5. Parties should ensure that their papers are uploaded accordingly and should refrain from emailing practice notes and draft orders to my clerk unless directed otherwise.

- 6. Should parties remove their matter from the roll, parties are required to email the notice of removal to the Judge's secretary and to upload it to CaseLines by no later than 06 JUNE 2024 at 16:00.
- 7. A draft order in Word and in PDF must be uploaded onto CaseLines on 06 JUNE 2024 by 16:00.
