DIRECTIVE:

1. The parties' attention is drawn to the Notice issued by the office of the Deputy Judge President on 19 February 2024, titled "*Important notice: changes to the Road Accident Default Judgment Court*" (Ref: DJP/373/2023/lt), particularly paragraph 2 thereof (including sub-paragraphs).
2. In light of the above, roll call for all matters will commence on **18 June 2024** at **10:00**, whereafter further directives will be issued and allocations made.
3. 4. If counsel is not present and has not been excused when the matter is called, the matter will be moved to the end of the roll and called again. If counsel is not present when the matter is called for a second time, the matter will be removed from the roll.
5. Parties must ensure that their matters are accessible on CaseLines (including matters that were initiated on CourtOnline). Should a matter not be accessible by **Friday, 14 June 2024** at **08:00**, parties run the risk of their matters being struck or removed from the roll.
6. Any affidavit evidence that a party intends to rely on, must be uploaded by no later than **18h00** on **Friday, 14 June 2024**. Parties run the risk of their matters being removed from the roll if any affidavit to be relied upon is not

uploaded by the prescribed date and time.

7. All practice notes, heads of argument and draft orders (in MS Word format) must be uploaded by no later than **18h00 on Friday, 14 June 2024**. Parties run the risk of their matters being removed from the roll if their practice notes and/or heads of argument are not uploaded by the prescribed time and date.
8. Plaintiffs' practice notes should include *inter alia* the following:
 - 8.1 Where general damages are claimed, a list of authorities with a brief description of injuries, figures awarded and the quantum of such award in present monetary terms.
 - 8.2 Where loss of income and/or income earning capacity is claimed, an address (no more than a page) on pre- and post-morbid scenarios as well as contentions in relation to both pre- and post-morbid contingency deductions.
 - 8.3 Where past medical, hospital and/or related costs are claimed, appropriate evidence on oath relating to the reasonableness and veracity of such costs should be uploaded to CaseLines.
9. Where an award claimed is to be protected by way of trust, the trust deed along with the trustee consent is to be uploaded to CaseLines.
10. The draft order must clearly reflect the surname of the judge (VAN NIEUWENHUIZEN AJ), date, the name of counsel, the attorney(s) and their respective email addresses. The draft order should be in a format ready to be made an order of court (i.e. the word "*draft*" should be deleted and if the phrase "*further and/or alternative relief*" appears in your draft order it must be deleted).
11. If there is a contingency fee agreement in place, the agreement itself must be uploaded to CaseLines. If settlement is reached between the parties prior to date of hearing, then and in such event the agreement must be uploaded to CaseLines along with compliant, Section 4 affidavits of attorney and plaintiff. Plaintiffs are strongly urged to peruse the Section 4 requirements in the attached case of **Hendry v RAF** and are impelled to ensure compliance therewith.
12. Please email the Judge's Secretary, Kholofelo Ramokgola (koramokgola@judiciary.org.za) should there any be any removals / withdrawals / settlements, as soon as possible.

13. The Acting Judge may communicate with the parties' representatives via widely shared notes posted on the electronic file. Legal representatives are to look out for these communications and are requested to respond to such communications.
14. Counsel are excused from introducing themselves in chambers. Introductions shall take place at the hearing of your matter.
