- 2. Queries regarding any urgent court application set down for hearing from 22 to 26 July 2024 must be addressed to the secretary of the presiding judge to whom the matter has been allocated for hearing.
- 3. Very important: Parties who do not wish to proceed with their matters should inform the Judge's secretary about such immediately upon receiving this roll or as soon as reasonably possible.
