JUDGE'S DIRECTIVES

1. All expert evidence shall be presented on affidavit.
2. Any evidence of a factual nature, upon which a party intends to rely, shall be presented on affidavit.
3. Practice notes, heads of argument and a draft orders, in word format, must be uploaded onto CaseLines on or before Friday, 20 July 2024.

5. Removals and settlements will be dealt with first.
6. The roll will be called as per chronological order and/or per seniority, at the Court's discretion.
