1. The Hon. Acting Judge Liebenberg will hear the matters hereunder in open court on the dates and times stated. (The relevant court number will be disclosed in due course – please see JSA website for daily court allocations).
 2. An appearance will be required in all matters (save for those that have been duly removed by Notice).
 3. Draft orders must be duly completed and compliant (i.e. must contain the details of counsel, reflect the date of the

hearing, and the Judge's particulars). Draft orders must be uploaded onto CaseLines in PDF and Word format, and Counsel must bring a copy to the hearing in court. This order must be signature ready (i.e. remove the word "draft" from the tramlines, delete the "further and/or alternative relief" prayer etc.) Orders will be delivered by uploading same onto CaseLines.

4. The attention of all parties is specifically drawn to the provisions of the relevant paragraphs of the Judge President's latest Practice Directive dealing with Practice Notes for Unopposed Motions. These are to be uploaded **at least one full court day prior to the date of the hearing**. The purpose of the Practice Note is to assist the Court in the efficient disposal of the matter. Accordingly, a Practice Note which merely describes what type of matter the Court is dealing with and/or does not refer the Court to the relevant documents and where these are to be found on Caselines, is of no assistance at all. The Practice Note should set out all the pertinent issues of the matter and precisely where each may be found on CaseLines. In this way, the Court will be able to ascertain whether the applicant is entitled to the relief sought or not.
5. Save as otherwise indicated, the matters below will be called in open court in the order that they appear on the roll, at 10:00 on Tuesday, 23 July 2024. If counsel is not present and has not been excused when the matter is called, the matter will be moved to the end of the roll and called again. If counsel is not present when the matter is called for a second time, the matter will be removed from the roll.
6. All material documents to be placed before the court, including practice notes and draft orders, must be uploaded to

Court Online and then made available on Caselines by no later than **noon on Friday, 19 July 2024**, failing which the matter may be removed from the roll.

7. It is emphasised that the parties are required to make their documents available on the Caselines system. The parties or their legal representatives must ensure that the Court Online entry is set so as to ensure that the whole file is available on Caselines. Matters not accessible on Caselines will be removed from the roll.
8. Matters numbered 4, 7, 14, 22, 23, 37 and 38 are provisionally removed from the roll because the papers are presently inaccessible on Caselines. The applicant's legal representative in each matter is advised to make urgent contact with the presiding Judge's Registrar.
9. When moving their matters, counsel will be expected to hand up a draft order in hardcopy.
10. Counsel are excused from introducing themselves in chambers.
