4. A practice note must be uploaded must include reference to when the application was served, how it was served and the nature of the matter.
5. The customary draft order (incorporating Counsel's name, email address and cell number) must be presented among the documents uploaded. **Parties are also requested to bring numbered hard copies of their draft orders to court.**
