- 1. All UNOPPOSED matters will be heard on Tuesday 30 July 2024 at 10h00 matters will be heard in open court;
- 2. Counsel need not introduce themselves in chambers, they may do so in court;

- 3. The parties are directed to create bundles on Caselines by no later than 12h00 on the 24th July 2024, failing which the matter may be removed from the roll.
- 4. A practice note must accompany all applications. The Applicant's failure to file a practice note, will result in a matter being removed.
- 5. All documents, practice notes and draft orders must be accessible on Caselines;
- 6. Parties must hand up hard copies of draft orders in duplicate;
- 7. Draft orders must be in word format, bear the date, name of the Judge and conclude with the following "By The Court_____ Registrar Online Enrolments;
- 8. Parties are requested to immediately notify the Judges registrar via email at NMvula@judiciary.org.za in the event that a matter becomes settled, postponed or is to be removed.
