FAMILY COURT DIRECTIVE (05 to 08 AUGUST 2024)

HEARINGS

1. All hearings (*unopposed, opposed and urgent*) before **GUNDELFINGER A.J.** will take place in Open Court (COURT 11C) without exception, including introductions, save for matters enrolled for hearing after hours in respect of which the Judge will give further directions.

REMOVALS/SETTLEMENT/UNOPPOSED MATTERS

- In matters that are removed/settled/unopposed draft Orders in Word format are to be uploaded onto CaseLines and e-mailed to the Judge's Secretary (*Lucky Mabasa*, telephone number: (010) 494-8366, and e-mail: <u>LMabasa@judiciary.org.za</u>) by no later than 13h00 on Friday, 02 AUGUST 2024 and bringing two hard copies of the draft Orders to Court.
- 3. These matters will be heard on Monday, 05 AUGUST 2024.

OPPOSED MATTERS: CASELINES, DRAFT ORDER, PRACTICE NOTE, HEADS OF ARGUMENT, AUTHORITIES BUNDLE AND HARD COPIES

- 4. All Court bundles are to be fully uploaded to CaseLines and be in compliance with PD1/2024. If any problems are experienced, the Judge's secretary, (*Lucky Mabasa, telephone number: (010) 494-8366, and e-mail: LMabasa@judiciary.org.za*), MUST BE CONTACTED TIMEOUSLY.
- 5. If a practitioner struggles to upload an Application to CaseLines, an Affidavit is to be prepared, explaining what steps have been taken and why it is not possible to upload to CaseLines and this must be sent to the Judge's secretary, (*Lucky Mabasa, telephone number:* (010) 494-8366, and e-mail: <u>LMabasa@judiciary.org.za</u>). The Judge will then give further directions.
- 6. It is the duty of the Applicant/Plaintiff's attorney to ensure that there are no duplicate cases and documents created on CaseLines and that sections are to be reader friendly in compliance with PD1/2024 at paragraph 7.7.
- 7. In matters as directed by the Judge, a hard copy of the papers filed on CaseLines, including in respect of the authorities bundle, are to be delivered to the Judge's secretary, (Lucky Mabasa, telephone number: (010) 494-8366, and e-mail: LMabasa@judiciary.org.za).
- 8. Draft Orders in Word format, are to be uploaded onto CaseLines and emailed to LMabasa@judiciary.org.za by no later than 12h00 on FRIDAY, 02 AUGUST 2024.
- 9. The matters will be heard on 06 August 2024.
- 10. Any further directives in respect of the matter will be e-mailed to the relevant parties.

- 11. If there is non-compliance with this Practice Directive and/or PD1/2024, the matter will be struck from the roll, unless good cause is shown for non-compliance.
- 12. With reference to PD1/2024, at paragraph 25.11, practitioners may not alter or request an alteration of the bundle in order to upload documents out of time. If it is established that a practitioner uploaded documents out of time, without condonation having been granted for such late filing, the matter may be struck from the roll and a cost order *de bonis propriis* may be made against the delinquent practitioner.
