- 3. Court commences at 10:00am
- 4. Parties/Counsel are required to hand in one physical copy of their draft order in court before the hearing commences or as soon as the matter is called to avoid court orders being endorsed after the hearing date.
- 5. PARTIES SHOULD ENSURE THAT THEIR PAPERS ARE UPLOADED ACCORDINGLY AND SHOULD REFRAIN FROM EMAILING PRACTICE NOTES AND DRAFT ORDERS TO MY CLERK UNLESS DIRECTED OTHERWISE.
