**PLEASE TAKE NOTE OF THE FOLLOWING DIRECTIVES:**

1. All Practitioners must ensure that all matters are accessible on Caselines, by 17:00, Friday, 23 August 2024 or they risk their matters being struck from the roll.
2. All unopposed matters must have a compliant Practice Note uploaded to case lines by 17:00, Thursday, 22 August 2024, with indexed Caselines references, if documents/annexures are referred to.

3. All **OPPOSED MATTERS** must have the following:
  - 3.1 A joint compliant Practice Note, in the event that this is not possible, a practice note **by both** the Applicant and the Respondent/s, uploaded to case lines by 17:00, Thursday, 22 August 2024, with indexed Caselines references, if documents/annexures are referred to.
  - 3.2 **In respect of Rule 43 Applications**, a comparative Indexed table, setting out succinctly the issues in dispute. Where Financial Disclosure Forms have been uploaded to Caselines, these need to be dealt with in the comparative table. If either party intends relying on bank statements, a statement by Counsel, acting for each party, to the effect that these statements have been perused and that they accord with the Financial Disclosure Form pertaining to the income and expenses of the parties, and if not, in what respect they do not so accord and the reasons therefor.
  - 3.3 Concise heads of argument uploaded to case lines by 13:00, on the 23 August 2024 by both the Applicant and the Respondent.
4. A draft order must be uploaded to Caselines in every matter by 17:00, Thursday, 22 August 2024 and a hardcopy with the date and the name of the Judge must be brought to court.
5. Unless notified to the contrary by the Judge's Secretary on email, all **Unopposed Applications** will be heard in open court on Monday, 26 August 2024 at 10:00.
6. Introductions will take place on each Court Day, as necessary at 09h45 at chamber 1003.
7. The Roll will be called as follows, all postponements and removals may be mentioned first, whereafter matters will be heard by seniority.
8. **Opposed applications (if any) will begin on Tuesday, 27 August 2024 and will be heard in open Court.** The court will endeavour beforehand to allocate approximate times for hearing to obviate wasting time of counsel, based on seniority and dependent on the urgent roll. There will be no need for counsel in Opposed Applications to attend roll call if they have already been allocated, a time and date for the hearing of the application, unless they require to do so for any specific reason.

9. Urgent applications will also be heard in open Court and will be allocated times for the hearing by the Court by way of an email from the Judges Secretary, failing which will be called or must be mentioned at 10:00 on Tuesday, 27 August 2024 or as and when set down, if there is a justified deviation from the “Thursday to Tuesday” rule.
