Practitioners must ensure that all matters are accessible on Caselines by 17h00 on Friday 23 August 2024 or they risk their matter being struck from the roll.</li><li>2. Every matter, opposed and unopposed, must have a compliant Practice Note uploaded to Caselines by 17h00 on Thursday 22 August 2024.</li><li>3. Opposed matters must have concise Heads of Argument also uploaded to Caselines by 17h00 on Thursday 22 August 2024.</li><li>4. A Draft Order must be uploaded to Caselines in every matter by 17h00 on Thursday 22 August 2024 and a hard copy with the date and the name of the Judge must be brought to Court.</li><li>5. Unless notified to the contrary by the Judge's Secretary on email, all Unopposed Applications will be heard in <b>open court on Monday 26 August 2024 starting punctually at 10h00.</b></li><li>6. Introductions will take place on each Court day as necessary at 09h45 at Chamber 811</li></ol>	

7. After postponements and removals, matters may be mentioned in order of seniority
8. **Opposed Applications will begin on Tuesday 27 August 2024 and will be heard in open court.** The Court will endeavour beforehand to allocate approximate times for their hearing to obviate wasting time of counsel, based on seniority and dependent on the Urgent Roll (if any). There will be no need for counsel in Opposed Applications to attend a roll call if they have already been allocated, by email, a time and date for the hearing of their application, unless they require to do so for any specific reason.
9. Urgent Applications, also to be heard in open court, will be allocated times for their hearing by the Court by way of email from the Judge's secretary, failing which will be called or must be mentioned at 10h00 on Tuesday 27 August 2024, or as and when set down if there is a justified deviation from the "Thursday for Tuesday" rule.
