- 1. All hearings will be conducted in **open court at 10h00**, The court room will be announced in due course. Parties may further check court room allocations on the JSA Bar website: https://www.johannesburgbar.co.za/court-rolls/.
- Parties must bring ONE hard copy of Draft Order sought. Draft Order must correctly
 indicate the Judge's name (i.e. PIENAAR), date on which the matter was heard, in which
 Court; number on the roll and the end of the draft order the party must indicate the name
 and contact details of their counsel and their instructing attorney.
- 3. A Practice Note is to be filed on Caselines by no later than 16h00, two clear days before the matter is to be heard, stating the nature of the application, the date and number on the roll and contact details (including email address/es) of the legal practitioner. All pleadings to be uploaded. No practice notes or other documents or pleadings to be uploaded without the prior knowledge and consent of the Judge.

- 4. Notices of removals or postponements which occur before **13h00** the day before the matter has been set down must be uploaded onto Caselines and also emailed to the email address **mmagadla@judiciary.org.za**.
- 5. To assist the Judge in the deliberation of the matters on her roll and to prevent matters from being struck, parties should ensure compliance with the relevant practice directives.
- 6. Parties must ensure that a case profile is created for their matter on Caselines and bundles/documents are uploaded thereto timeoulsy.
- 7. Introduction to the Judge shall take place at 9:30 in office 1103 on the 11th floor at the High Court.
