4. If counsel is not present and has not been excused when the matter is called, the matter will be moved to the end of the roll, and called again. If counsel is not present when the matter is called for a second time, the matter will be removed from the roll.
5. When moving their matters, counsel will be expected to hand up a draft order in hardcopy. Where settlement agreements are sought to be incorporated into the draft orders by reference, the settlement agreements must be annexed to the drafts handed up.
6. **Counsel are excused from introducing themselves in chambers.**
