#### **DIRECTIVES**

- Documents must be uploaded in all matters to the CaseLines digital platform, including in instances where it is a CourtOnline matter, save where a Judge, in exercising a discretion, permits the documents to be served by email. A matter which is non-compliant with this requirement shall not be entertained. Only matters that have been uploaded on CaseLines shall be heard. All non-compliant matters will be removed from the roll.
  - Litigants who struggle with bundling their files from CourtOnline to CaseLines are to follow the attached 7 step user manual. Alternatively, contact the help desk using the information below:

- 2. If any Applications are to be removed or settled, this should be conveyed to Ms Buys by way of e-mail, as soon as possible.
- 3. The hearing of all urgent applications (both opposed and unopposed) will be conducted as videoconferences using the Microsoft Teams platform. The link to the videoconferences must be obtained from this roll as it will not be emailed separately.
  - Counsel are required to remain on standby in the MS Teams hearing, despite the time allocation. Should a matter be finalised earlier than expected, the next matter will be called.
- 4. **Self-represented litigants** will be accommodated in office 1236 at the Johannesburg High Court, in circumstances where they do not have access to their own facilities to join the videoconference via MS Teams; attorneys are required to advise unrepresented litigants of same, where possible.
  - 4.1. Self-represented litigations making use of the Courts facilities are required to be at court by no later than 09h00 on the day of their hearing.
  - 4.2. Please ensure that you inform <a href="mailto:EBuys@judiciary.org.za">EBuys@judiciary.org.za</a> / 010 494 8558, by no later than 08h30 on the day of your hearing, of your attendance at court.

- 6. Stamped and signed copies of draft orders will be uploaded onto CourtOnline/CaseLines within a day of the order being granted.
- 7. The MS Teams links have been attached below. Parties are required to use the link as per their allocation date.
  - ie the MS Teams link under Tuesday, 16 July 2024 should be used by everyone, to join that respective hearing for a roll call to be conducted.
  - Thereafter, depending on which day your matter has been allocated to, please use the MS Teams link of that respective day.
  - Counsels' mere indication of a date preference on their papers will not suffice. Counsel are still requested to avail themselves for roll call to formally request & confirm the date.
