 - 6.7. pleadings;
 - 6.8. expert reports;
 - 6.9. offer of settlement from the RAF;
 - 6.10. proposed draft order communicated to the RAF and proof of such communication;
 - 6.11. letter of confirmation;
 - 6.12. contingency fee agreement (if applicable);
 - 6.13. draft order.

7. Legal practitioners are requested to upload short heads of argument and the proposed draft order.
