5. Documents must be uploaded in all matters to CaseLines. Only matters that have been uploaded on CaseLines shall be heard. Matters initiated on

Court Online must be bundled to Caselines in accordance with the Practice Directives and "7 steps to bundle". If matters are not bundled to

Caselines by 13h00 on 27 September 2024, the matters will be removed.

6. Bundles on *CaseLines* will be frozen as at **13H00 on 27 September 2024**, any further communication relating to matters on the roll must be emailed

to <u>UReddy@judiciary.org.za</u>. In the event that the matter is opposed, answering and replying affidavits must be emailed to

7. Where a duplication of matters exists, parties must bring same to the attention of Mr Reddy by no later than 13h00 on 27 September 2024 and

direct him to the correct matter, failure to do so will result in the matter being removed/struck off the roll.
