# THIRD DIRECTIVE BY GOODENOUGH AJ DEFAULT JUDGMENT ROLL FOR WEEK STARTING 30 SEPTEMBER 2024

- 1. The Civil Trial Default Judgment court before Honourable Goodenough AJ will be heard on MS Teams.
- 2. Roll call of all the Civil Default Judgment matters on the week's roll with start promptly at 10:00 on 01 October 2024 (Tuesday), during which Counsel/attorneys should give an update on the status of their matters. Allocation of matters that are proceeding by default will be done by Honourable Goodenough AJ at Roll Court.
- **3.** As a result of my preliminary reading on Case Lines of the papers in the default judgment applications, the need for this further directive has become apparent:
- **4.** I draw practitioners' attention to Rule 31 (4) read with (2) and (3):
- **4.1.** If there is no proper Notice of Set Down uploaded on to Case Lines setting out the terms of the order being sought by way of default judgment and/or;

- 4.2. no proof of timeous service, then the matter will be removed from the roll, unless RAF's legal representative appears at the hearing and informs the Court that RAF is aware of the terms of the order being sought. If the RAF was only made aware of this at the last minute then Plaintiff risks the matter being postponed at Plaintiff's cost.
- 5. Kindly ensure that affidavits are uploaded to Case Lines to confirm all the material facts plus all the expert opinions being relied upon as a basis for seeking default judgment:
- **5.1.** The expert reports and affidavits do not constitute proof of the factual allegations on which they are based.
- **5.2.** Affidavits by the Plaintiff or injured person or other relevant factual witnesses must be uploaded in support of the factual basis of the application.
- **5.3.** It will be acceptable for an affidavit by the Plaintiff or injured person to state that they have read the experts reports of a list of specifically named and dated expert reports and that they confirm that the factual contents thereof is true insofar as it relates to that Plaintiff.
- **5.4.** The presiding judge may or may perhaps not decide in some matters that oral evidence is to be given, but do not assume that oral evidence will be called for. Every material fact and every expert opinion on which Plaintiff relies must be supported by uploaded affidavits before the hearing.
- **6.** The papers should be in order when the matter is called. No matter will stand down until later in the week.
- 7. Draft orders must already be uploaded to Case Lines when the matter is called.
- 8. Legal Practitioners may introduce themselves as and when their matters are called.
- **9.** The Draft Order should set out the date of hearing, Judge's surname (Goodenough AJ), number on the roll, last page the details of Counsel/Practitioner' details. If the order is granted same should be emailed immediately in word format to Mr. Magadla (Mmagadla@judiciary.org.za).
