**URGENT COURT DIRECTIVE: 15 – 18 OCTOBER 2024**

**BEFORE JUSTICE LE GRANGE AJ**

1. There shall be physical hearing at Court allocated by the Registrar on the day roll at 10h:00. Virtual hearing will be conducted only for matters lodged afterhours, weekends, public holiday and parties must arrange with the secretary working afterhours for a link.
2. Any settlements & removals received by the litigants will be attended too on Tuesday 15 October 2024 at 10:00. Parties are requested to notify the secretary timeously through email and further attach the draft order, settlement agreement, consent from both parties. Counsel will be excused to attend court if matter is removed by Notice and same has been transmitted to the secretary.
3. Introductions before Acting Judge Le Grange will be conducted on day of the hearing at 09h:45, Office 249 Palace of Justice. Parties are urged to be punctual.
4. A practice note must be filed by all parties appearing in a matter, dealing specifically with urgency, giving a brief synopsis of the matter, and outlining the issues to be decided. The practice note shall be filed on CaseLines by no later than 12h:00 on Saturday 12 October 2024.
5. Parties shall attend court with 1 hard copy of their Heads of Argument, List of Authorities if any and 1 Copy of the proposed Draft orders depicting the details of the court room (i.e to be allocated by the Registrar) Judge presiding over the

matter (Acting Judge Le Grange AJ) and the details of the instructing attorneys and appearances on the last page.

6. Matters are allocated with specific dates and parties must appear on the date allocated.
