  Judge President's Consolidated Practice Directive 1 of 2024 and that the parties
  advise whether they are in agreement regarding the mode of hearing.

### 4. Please note:

- 4.1. To assist the Judge in the deliberation of the matters on her roll and to prevent matters from being struck, consideration of compliance with the relevant directives pertaining to opposed motions will apply.
- 4.2. Parties should ensure that proposed draft orders are uploaded in word format onto Caselines at least a day before a particular matter will be heard. Draft orders should indicate the hearing date of the matter, the Judge's name, and the manner in which the matter will be heard (i.e. open court), and at the end of the draft order the names and details of all

- counsel/practitioners and of their instructing attorneys must be included.
