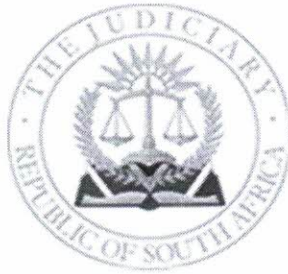
Urgent Court Directive for matters on the roll before Judge van der Westhuizen:

1. All matters will be heard in open court;
2. Roll call will be held on Tuesday, 21 January 2025 at 10:00 in open court allocated by the Registrar on the day roll. All the parties must be ready to proceed with their matter on the day, although some matters may be allocated to later in the week;
3. Parties are not entitled to set down their matters arbitrary other than the Tuesday of the Urgent Court week. All parties must attend roll call if not allocated a specific date by the Judge before roll call;
4. There must be proof of service on caselines in all the matters before Judge van der Westhuizen;
5. One copy of the Order/Draft order, where applicable, should be handed up in court. If the parties need a signed by the Judge only order, two copies must be handed up in court;
6. The order made in court, stamped and signed by the Registrar, will be uploaded onto caselines within 1 day after the order was made;
7. No documents or orders should be e-mailed, everything must be uploaded on caselines;
8. Please inform our office as soon as possible if a matter is to be removed or has settled;
9. It is not necessary for Legal Practitioners to introduce themselves to the Judge in chambers as they may do so when their matter is called in court.

* If the parties are not in court at the end of roll call, their matters will be struck from the roll.
