MINNAAR AJ: DIRECTIVE: TRIAL INTERLOCUTORY ROLL 27 TO 31 JANUARY 2025:

1. The trials/special interlocutory court rolls of 27 to 31 January 2025 will be called physically in court and the hearing will begin strictly at 10:00. Parties are to verify the court venue on the date of hearing.
2. Introductions to take place in court.

3. The roll will be called as follows: Postponements, removals and settlements followed by order of seniority.
4. All documents, inclusive of the practice note and draft order to be uploaded by 16h00 **two days prior** to the date of the hearing.
5. Draft orders to correctly contain the spelling of the Judge's surname: "MINNAAR" and should contain the number on the roll at the top left corner of the draft order. Counsel's details are to be included in the draft order.
6. **In all applications** a practice note must be filed setting out at least:
 - 6.1 Particulars and contact details of the legal practitioners;
 - 6.2 Nature of the relief sought (without referring to the notice of motion);
 - 6.3 A brief summary of the factual as well as legal issues involved;
 - 6.4 A clear indication which portion of the papers must be read and which not;
 - 6.5 Service should be pointed out;
 - 6.6 If applicable: statutory requirements that had to be met; and
 - 6.7 A statement that the papers are in order (if the papers are not in order, then the difficulty or shortcoming should be pointed out).

Failure to file a practice note setting out all the above information may result in the application be struck off the roll.

7. All bundles should be uploaded in such a fashion that pleadings and annexures are easily identifiable. As an example: A combined summons should be uploaded in the following fashion (and this manner should be applied to all documents in all applications):

Section 001: Combined summons

1. *Summons pages 001-1 to 001-2*
 2. *Particulars of claim pages 001-3 to 003-15*
 3. *Annexure A: Written agreement pages 001-16 to 001-30*
 4. *Annexure B: Written letter of demand pages 001-31 to 001-33 etc.*
8. Mr Mabasa should be informed, preferably by way of email, as soon as possible if a matter is to be postponed or removed. Counsel should further post a note on Caselines should a matter be postponed or removed.
9. Counsel to be mindful of notes made by Minnaar AJ on Caselines and to comply with same.
