DIRECTIVES

- 1. Parties must ensure timeously that the files on comply fully with Revised Consolidated Practice Directive 1/2024, in particular paragraphs 7, 28, and 29 thereof, and any other paragraphs that may be relevant to that particular matter. PARTIES ARE REMINDED THAT EVERY NON COMPLIANCE OCCASIONED BY URGENCY MUST BE PROPERLY SUBSTANTIATED. FAILURE TO COMPLY MAY RESULT IN THE MATTER NOT BEING ENTERTAINED.
- Matters that have not been migrated to Caselines will not be entertained unless timeous arrangements have been made with the presiding judge. Matters to which the senior judge does not have access cannot be allocated.
- 3. Should any of the parties have any doubts about the correct directive, please contact Mr. Tshabalala through his email.
- 4. A Practice Note relevant to this hearing, and properly labelled, must be uploaded timeously.
- 5. Draft orders must be duly completed and compliant. Draft orders must be uploaded in PDF and Word format, and legal representatives must also bring a hard copy of the order that is signature ready.

- 6. Litigants with matters with notes that reads "No Access" or "Bundle not Created" are to ensure that their matters are bundled and migrated to Caselines as soon as possible and to advise via email once migration has been done.
- 7. Parties should note that a Judge's Clerk cannot assist parties in creating the bundle and uploading documents on CourtOnline or CaseLines. The legal representative, or any party appearing in person, should liaise with the CourtOnline helpdesk.
- 8. Each judge's chambers will in addition issue a separate allocated roll with specific directives.
