- 5. Should parties remove their matter from the roll, the parties are to email the relevant Judge's Secretary a Notice of Removal timeously and are to upload the Notice to the electronic file
- 6.Practitioners who initiated their files on Court Online are to promptly create an online bundle in preparation for the hearing of their matters to avoid removals from the roll and last-minute duplication of matters between the CaseLines and Court Online system.
