**DIRECTIVES: URGENT COURT BEFORE YACOOB J 17-21 FEBRUARY 2025**

2. All unopposed matters will be heard at 10h00 on Tuesday, 18 February 2025, after roll call.
3. Parties in opposed matters are requested to upload a practice note indicating any request for when their matter should be heard. The court will do its best to accommodate such requests but there is no guarantee. The practice note must be uploaded by 17h00 on 14 February 2025 and an updated roll including dates and times for opposed matters will be published on Monday 17 January 2025.

4. Counsel wishing to introduce themselves may do so at 09h45 on the day of their hearing at the judges' chambers.
5. Those matters identified below as having NO ACCESS/ NO CASELINES BUNDLE/ NO APPLICATION SET DOWN FOR THE WEEK 17-21 FEBRUARY 2025 must be rectified by 17h00 on FRIDAY 14 FEBRUARY 2025 and an email sent to the chambers of Yacoob J confirming that this has been done. The matter will then be allocated.
6. Failure to do this will result in the matter not being allocated and being struck from the roll.
7. Any matters on the consolidated roll which remain unallocated and in which parties wish to make submissions will be dealt with at roll call on Tuesday 18 February 2025 at 10h00.
