2. Parties are to ensure that they have complied with the relevant practice directives and the rules of this court, and that any deviation therefor is properly substantiated.
3. Those matters which do not comply run the risk of not being dealt with, or of adverse costs orders being made.
4. Draft Orders must be uploaded in MS Word format on Court Online and Caselines and be available in hard copy to hand up at the hearing. ALL DRAFT

ORDERS MUST HAVE A DISCLAIMER CLAUSE and indicate the date and particulars of the Judge.

5. The Practice Note, Draft Order and Heads of Argument (if applicable) must be filed by **17:00 am on the last court day** before the hearing, after which the matter will be frozen.
6. Filing must be done on CASELINES ONLY (and NOT emailed to Ms N Makgalefa, unless otherwise indicated).

It is the responsibility of the applicant's attorney to ensure that the matter is TIMEOUSLY, PROPERLY AND FULLY uploaded onto Case lines and that the Judge and her clerk will have access to the matter at the latest at 12:00 on the day before the date of hearing to enable the Judge to read the papers.
7. Late filing or updates will not be accepted.
8. If the matters are not visible on caselines and the bundles are not reflecting in order as to the sections on court online, the matter will be removed.
