 - Counsel are required to remain on standby, despite the time allocations. Should a matter be finalised earlier than expected, the next matter will be called thereafter.

 - Please replace the wording “draft order “with “court order” on your draft orders.
4. Stamped and signed copies of draft orders will be uploaded onto Court Online/CaseLines within 5 days of the order being granted.
 5. **Counsel’s mere indication of a date preference on their papers will not suffice.**
 6. **Draft Orders in word and pdf format must be in the correct format, concluding with “BY THE COURT”**
 7. **Introductions will be done at 09h30 and no later than 09h45.**
