## **JUDGE'S DIRECTIVE**

- 1. The applicant is requested to deliver a hard copy of the application to the Judge's secretary at room 408 by no later than 16h00 on Wednesday, 5 March 2025. The pagination must be consistent with the CaseLines' pagination. A hard copy of the authorities which will be relied upon in argument must be available at the hearing for the benefit of the Judge.
- 2. The roll for the week will be called in open court at 10h00 on Monday, 10 March 2025. Legal practitioners should, however, remain available to argue the application on any day in the week. Specific allocations made before roll call will be communicated to the relevant legal practitioners.
- 3. All matters should comply with the provisions of chapter 9.8 of the Practice Manual of the Gauteng Local Division of the High Court of South Africa, Johannesburg dated October 2018 ("the Practice Manual") and chapter 25 of the Revised Consolidated Practice Directive 1 of 2024 Court Operations in the Gauteng Division ("the Consolidated Directive"), in particular paragraphs 25.17 25.19. Where there has not been compliance with the provisions of paragraphs 25.17 25.19 of the Consolidated Directive, such non-compliance should be cured by no later than 16h00 on Tuesday, 4 March 2025, but those matters will not necessarily be heard in the absence of good cause being shown.
- 4. Non-compliance with the Practice Manual, the Consolidated Directive or this directive may result in the application being struck from the roll, unless good cause is shown for the non-compliance.

- 5. Where an updated practice note and heads of argument have not been filed, an updated practice note and heads of argument must be uploaded to CaseLines by no later than 16h00 on Tuesday, 4 March 2025, but those matters will not necessarily be heard in the absence of good cause being shown.
- 6. If an application will not be proceeding, legal practitioners are urged to upload to CaseLines, as soon as reasonably possible, a note to that effect and inform the Judge's secretary by email.
- 7. No further documents, save for draft orders, practice notes and heads of argument, may be uploaded to CaseLines without the Judge's written consent obtained by email through the Judge's secretary.
- 8. It is necessary that care is taken when preparing draft orders. Court orders are public documents. Draft orders must be marked with the letter "X" in large font (or manuscript) in the top right-hand corner of the first page together with the date alongside it. The following information must appear on all draft orders:
  - 8.1. Date.
  - 8.2. The Judge's name and description:

"P G LOUW AJ"

8.3. The name and contact details of counsel and the instructing attorney.

8.4. The preamble to the draft order must read as follows:

"Having heard counsel and having considered the matter, the following order is made:"

8.5. All draft orders must be uploaded onto CaseLines in Word format and two copies must be available for handing up for signature by the Judge at the hearing.
