Moultrie AJ's Directions (Friday, 14 March 2025, 10h30)

- 1. Moultrie AJ's urgent roll for week 9 will be published as soon as it is available.
- 2. A roll call will be held in <u>open court at 10h00 on Tuesday, 18 March 2025</u> at which all of the matters on Moultrie AJ's roll (save in respect of matters in which representatives may be advised otherwise by means of a note shared by Moultrie AJ or his secretary on CaseLines, or by email) will be called and either (i) heard; or (ii) allocated to a later time in the week for hearing. The court number will be identified in the daily roll published by the office of the Deputy Judge President.
- 3. Applicants in all matters are directed to ensure that a paginated bundle is available on CaseLines by no later than <u>16h00 on Friday</u>, <u>14 March 2025</u> containing all documents filed of record in the matter as at that time, and to ensure that Moultrie AJ's secretary and all parties representatives are "invited" to the case.
- 4. Any document filed by any party after 16h00 on 14 March 2025 must be both (i) uploaded onto CaseLines; and (ii) emailed to the Judge's secretary on the email address above. In addition, all such documents must (save in exceptional cases where this is impossible) be duly filed on CourtOnline before being uploaded onto CaseLines and emailed, and the document uploaded and emailed must be the version of the document that was filed on CourtOnline (i.e. containing the CourtOnline cover sheet showing time of filing and watermarks).
- 5. Counsel or attorneys appearing for each party should <u>upload and email a practice note</u> (STRICTLY limited to 4 pages) containing (i) their cellphone and email contact details; (ii) an estimation of the likely duration of the hearing; and (iii) brief submissions with reference to

relevant authority by **no later than 13h00 on Monday, 17 March 2025**. Applicants should similarly deliver a complete draft order in Word format and bring a hardcopy thereof to court.

- 6. Representatives must ensure that the uploading of any document to the CaseLines file after 16h00 on 14 March 2025 does not affect the pagination of any other document in the bundle as at that time.
- 7. Save as set out above, paragraphs 24.10 (dealing with return dates for rules nisi), 12.25 and 28 of Practice Directive 1 of 2024 (revised 12 June 2024) as well as the Pretoria Practice Manual will be applied. Further or amended directions may be published via "widely shared notes" posted on the CaseLines file, and parties are required to look out for these communications and to respond to such communications as requested.
- 8. Any party unable to comply with any of the directions set out above, or becoming aware of any fact that may affect the smooth operation of the court must contact the judge's registrar, copying the legal representatives of the other parties if any, <u>as soon</u> as they become aware of such inability or fact.
