CIVIL TRIAL DEFAULT JUDGMENT

Guidelines for proceedings in the DJ Court – 1st Term 2025

- 1. All documents must be available on CaseLines failing which matters will be removed or struck from the roll.
- 2. The Practice Directives for this court must be strictly adhered to including the timeous uploading of Practice Notes. Failure to do so will lead to the removal or striking of the matter.
- 3. Parties are to notify our office by e-mail of any removal, postponements or settlements forthwith, to prevent the unnecessary reading of matters.
- 4. Proceedings will be conducted in person in Court 8A on the 8th floor (also check daily roll if there is a change in court) of the court building and will commence at 10h00.
- 5. If there is to be an application for a separation of issues it must be done in advance, either by formal application or by indicating that an application will be moved from the Bar in the practice note, to prevent unnecessary reading.
- 6. On Tuesdays the court will deal first with removals and settlements where after, for the remainder of Tuesday, matters will be called in order of seniority, thereafter the remaining matters will be called in the order that they appear on the roll.
- 7. Any representative that wish to lead evidence via affidavit must be in a position to assure the court that the signature on the affidavit is an original signature and not a stamp.
- 8. The draft orders in PDF and Word format must be uploaded timeously and must include the presiding judge's name on the draft order.
- 9. Hard copies of the drafts must also be available in court.
