- 1) The hearings will be conducted in open court unless otherwise advised.
- 2) All documents, heads of argument and practice notes must be accessible on CaseLines. If not, practitioners risk their matters being struck off the roll.
- 3) PRACTICE NOTES ARE TO BE FILED BY NO LATER THAN THURSDAY 17TH APRIL 2025 AT 14H00.
- 4) Matters in which practitioners fail to upload a practice note timeously risk being removed or struck from the roll. Practice notes and draft orders sent by email will not be accepted. They must be accessible on CaseLines and uploaded within the stipulated timeframe.
- 5) Practitioners are reminded to remain available in case their matter is called earlier than appears on the roll below.
- 6) Parties are to notify our office in writing of any removal, postponements or settlements forthwith.
- 7) Draft Orders in word and pdf format must be in the correct format, concluding with: “BY THE COURT”
