- 1. Introduction will be done in the court.
- 2. Applications will be heard in open court and will commence at **09:00 am.**

- 4. All court orders must be uploaded onto CaseLines in word format and copies must be available for handing up for signature by the Judge.

- 6. Practitioners are urged, prior to moving an application, to consider notes, if any, annotated by the Judge on Case Lines.
- 7. The parties must make sure that they have submitted their heads of arguments and practice notes. Parties are further advised that the times that have been suggested in the practice notes will strictly be adhered to.
- 8. Counsel must be available in the event of removal, settlement or postponement of matters before the court.
