1. The Hon. Judge Kumalo will hear the matters hereunder in open court on 5 May 2025- 9 May 2025 at 10 AM. (The relevant court number will be disclosed in due course – please see JSA website for daily court allocations).
 2. An appearance will be required in all matters (save for those that have been duly removed by Notice).
 3. Draft orders must be duly completed and compliant (i.e. must contain the details of counsel, reflect the date of the hearing, and the Judge's particulars). Draft orders must be uploaded onto CaseLines and Counsel must bring a copy to the hearing in court. This order must be signature ready (i.e. remove the word "draft" from the tramlines) **Orders will be delivered by uploading same onto CaseLines for CaseLines matters, and on Court-Online for Court Online matters.**
 4. Please note that the Judge's surname is spelt without the "H".
 5. If counsel is not present and has not been excused when the matter is called, the matter will be moved to the end of the roll and called again. If counsel is not present when the matter is called for a second time, the matter will be **struck off** from the roll.

6. It is emphasised that the parties are required to make their documents available on the Caselines system.
7. Note that it is not the judge's secretary's duty to ensure that the parties documents are available on Caselines.
