- 3. Introductions in chambers are not necessary.
- 4. Proposed draft orders should be emailed to judge's registrar in word version (name of the parties and case number) in the subject line. Please ensure that the Judge's name, **F Bezuidenhout** appears at the top and the details of the counsel appears at the bottom of the order. The court heading must read "Gauteng Division, Johannesburg".
- 5. All papers, heads of argument and practice notes must be filed by no later than **Monday**, **12 May 2025 at 09h00**. The annexures of affidavits must be uploaded and identified separately.
- 6. ALL documents in all matters must be uploaded to the CaseLines digital platform, including in instances where it is a Court Online matter. A matter which is non-compliant with this requirement runs the risk of being struck off. Only matters that have been uploaded on CaseLines will be heard.
