DIRECTIONS

PLEASE NOTE THE FOLLOWING DIRECTIONS BY THE PRESIDING JUDGE:

1. HEARING DATE; TIME; MODE; AND VENUE:

- a) All matters are to, respectively, proceed on the date(s) and time(s) indicated herewith.
- b) Proceedings will take place in an OPEN courtroom.
- c) Only in exceptional justice-oriented circumstances, deemed by the Presiding Judge to be aiding in getting the matter expeditiously disposed of, and by prior arrangement with the Judge's Registrar, a virtual hearing mode, alternatively proposed (and agreed-upon by both parties) may be resorted to.

2. APPEARANCE:

- a) Appearance will be required in all matters, save for those that have been duly removed by notice.
- b) Thus, notice(s) of Removal must be uploaded as reasonably early as possible to avoid the need for physical appearance or rather, at the very least, a rational expectation of it by the Court.

3. LEGAL REPRESENTATIVES ARE TO ENSURE THAT:

- a) all of their matters are accessible;
- b) the interface bundle is created for all Court-On-Line matters, if any at all, to be accessible on CaseLines by both the presiding Judge and his Registrar in the main;
- c) updated Practice Note (of a joint nature, where applicable) is accordingly and duly uploaded. It ought to be borne in mind moreover that the purpose of the practice note is to assist the Court in the efficient disposal of the matter. Thus, the practice note at issue should set out all the pertinent issues of the matter and precisely where each may be found on CaseLines. In this way, the Court will be well placed to ascertain whether or not the applicant is entitled to the sought relief.
- d) a complete set of papers has accordingly been uploaded.

4. DRAFT ORDERS:

- a) Draft Orders must be duly completed and compliant (i.e. they must contain the details of counsel; reflect the date of the hearing; and, reflect the Judge's particulars).
- b) In line with para 3(a)(b) and (d) above, Draft Orders must be uploaded onto CaseLines, of which Counsel must, in addition thereto, physically bring one hardcopy to the hearing in Court.
- c) These orders must be signature ready (i.e. remove the word "draft" from the tramlines, delete the "further and/or alternative relief" prayer etc.).
- d) Accordingly marked, signed and stamped Court Orders will finally be delivered using platforms at the disposal of the respective parties.
- e) The Judge may communicate with the parties' legal representatives via widely shared notes posted on the electronic file. Legal Representatives are to look out for these communications and are requested to respond to such communications.

7. HEADS OF ARGUMENT:

- a) Parties are required, through their Counsel, to accordingly file Heads of Argument.

8. INTRODUCTIONS:

- a) Unless otherwise there is anything pressing that the parties would like to bring to the attention of the Judge in the chamber(s) or corridors (especially in a case where a matter is to be heard openly), Counsel will introduce themselves in Court upon their matters being called on record.
- b) For further information or just about any other related queries, parties are at liberty to get hold of Ms Boipelo Tlhowe, her details and time and way(s) of contact of which appear on the face of the roll above.
