*“This order is made an order of court by the Judge whose name is reflected herein, duly stamped by the registrar of the court, and is submitted electronically to the parties/their legal representatives by e-mail. This order is further uploaded to the electronic file of this matter on CaseLines by the*

*Judge or the Judge's secretary. The date of this order is deemed to be the date of hearing of the matter."*

8. Allow at least a few days for signed court orders to be uploaded on to the CaseLines platform. Orders which are to be signed urgently must be mentioned in Court.
