DIRECTIVE OF THE HON. ACTING JUDGE PULLINGER

- 1) The Hon. Acting Judge Pullinger will hear the matters hereunder in an open court on the date stated. (Please see JSA website for daily court allocations).
- 2) **Court will begin at 09:00** and matters will be called number by number.
- 3) There will be no introductions in the Chambers.
- 4) If any matter is to be removed from the roll, they should notify the Secretary timeously.
- 5) An appearance will be required in all matters (save for those that have been duly removed by Notice).
- 6) Draft orders must be duly completed and compliant (i.e. must contain the details of counsel, reflect the date of the hearing, the correct case number as per the court roll and the Judge's particulars).
- 7) Draft orders must be uploaded onto CaseLines in PDF and Word format, and Counsel must bring a copy to the hearing in court.
- 8) The orders must be signature ready (i.e. remove the word "draft" from the tramlines, delete the "further and/or alternative relief" prayer etc.)
- 9) The case number MUST be correctly inserted as per the court roll.
- 10) The attention of all parties is specifically drawn to the provisions of the relevant paragraphs of the Judge President's latest Practice Directive dealing with Practice Notes for Unopposed Motions. These are to be uploaded at least one full court day prior to the date of the hearing. The Practice Note should set out all the pertinent issues of the matter and precisely where each may be found on CaseLines.
- 11) Parties with CourtOnline matters must follow the "7-Steps" to ensure that their CourtOnline matters bundle onto CaseLines.
- 12) Please be advised that the signed and stamped court orders will be uploaded within the 5 to 7 working day period as set out in the Practice Directive.
