- 2. Introductions by counsel who have not appeared before Hon. Judge Seboko (AJ) will be done on the 8<sup>th</sup> floor, in chambers 803 at 09:45am.

- 3. Parties/Counsel are required to hand in (<u>ONE</u>) physical copy of their draft order in court before the hearing commences or as soon as their matter is called to avoid court orders being endorsed after the hearing date.
