DIRECTIVE BY HONOURABLE JUDGE MAHOMED

- 2. An appearance will be required in all matters (save for those that have been duly removed by Notice).
- 3. Draft orders must be duly completed and compliant (i.e. must contain the details of counsel, reflect the date of the hearing, and the Judge's particulars). Draft orders must be uploaded onto CaseLines and Counsel must bring a copy to the hearing in court. This order must be signature ready (i.e. remove the word "draft" from the tramlines)

Orders will be delivered by uploading same onto CaseLines for CaseLines matters, and on Court-Online for Court Online matters.

- 4. If counsel is not present and has not been excused when the matter is called, the matter will be moved to the end of the roll and called again. If counsel is not present when the matter is called for a second time, the matter will be removed from the roll.
- 5. It is emphasised that the parties are required to make their documents available on the Caselines system.
