- 2. All hearings will be done in open court/physical court at Court 9A.
- 3. Parties are to ensure that they inform the judge's secretary immediately when there will be any removals or settled matters.
- 4. Parties should do a short practice note describing what the matter is all about, the anticipated duration, whether there is opposition (or any expectation of opposition), and the nature of the alleged urgency.
- 5. Parties must ensure that all the matters are uploaded onto Case Lines, even if you have filed on Court Online, as the court will proceed on that platform.
- 6. Parties must upload Draft orders incorporating Judge's name, date, and the number of the matter on the court roll. The draft order must also incorporate the counsel's name, email address and cellphone number. The draft order must also be printed and presented in court.
- 7. A respondent who, despite being late to do so, wishes to oppose the granting of an order, must communicate that fact by email to SRamncwana@judiciary.org.za and to the applicant and otherwise comply with this directive.
- 8. Counsel or attorney to an application must at once when it becomes known that there is opposition regardless of its merits, communicate this to SRamncwana@judiciary.org.za
- 9. Matters highlighted in red on the roll below, are not accessible on Case Lines. Parties are to ensure that they invite the judge's secretary on Case Lines SRamncwana@judiciary.org.za and inform her once they have done this. If the matters remains inaccessible by 17:00 on the 4 July 2025, they will be removed from the roll.
