- COUNSEL MUST HOLD THEMSELVES AVAILABLE TO BE HEARD EARLIER ON THE DAY FOR WHICH THEIR Ш MATTER IS ALLOCATED. COUNSELARE NOT EXPECTED TO HOLD THEMSELVES AVAILABLE FOR ANY DAY OTHER THAN THE DAY FOR WHICH THEIR MATTER IS ALLOCATED. IF ANY MATTER COLLAPSES, COUNSEL MAY BE APPROACHED TO ENQUIRE ABOUT IMMEDIATE AVAILABILITY ON A DAY OTHER THAN THE DAY ON WHICH THEIR MATTER HAD BEEN ALLOCATED FOR.
