- 7. All matters will be heard in open court on <u>Monday at 10h00</u> and on <u>Tuesday at 10h00</u> (please see the day-roll for the court that will be used for the hearing).
- 8. All introductions will be done in open court.
- 9. Parties are reminded to ensure that the judge's surname, the case number, roll number and parties names on the draft orders are correct as well as all annexures.
- 10. Only 1 draft order is required to be handed up.
- 11. The general Family Court Directives are to be STRICTLY complied with.
