7. All matters will be heard in open court on Monday at 10:00 and on Tuesday at 10h00 (please see the day-roll for the court that will be used for the hearing).
8. All introductions will be done in open court.
9. Parties are reminded to ensure that the case number, roll number and parties names on the draft orders are correct as well as all annexures.
10. Only 1 draft order is required to be handed up.
11. The general Family Court Directives are to be STRICTLY complied with.
