TRAMLINES, DELETE THE "FURTHER AND/OR ALTERNATIVE RELIEF" PRAYER ETC.) ORDERS WILL BE DELIVERED BY UPLOADING SAME ONTO COURTONLINE/CASELINES AND TO ENSURE THAT THEIR COURTONLINE MATTERS BUNDLE ONTO CASELINES.

3. MR LETSOALO MUST BE INFORMED IMMEDIATELY WHEN MATTERS ARE REMOVED FROM THE ROLL, SETTLED OR POSTPONED TO AVOID THE UNNECESSARY READING OF THE PAPERS.
