4. Draft Orders must be uploaded in MS Word format on Court Online and be available in hard copy to hand up at the hearing. Ensure that the draft orders comply with the Court Directive and outline the Judges' name, date, the number of the matter on the roll, mode of hearing and the following disclaimer:

*"This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by email. This Order is further uploaded to the electronic file of this matter on Case Lines by the Judge or her Secretary. The date of this Order is deemed to be \_\_\_\_\_.*
5. If the matter becomes opposed, parties must submit brief heads of argument as soon as practicable.
6. It is the responsibility of the applicant's attorney to ensure that the matter is TIMEOUSLY, PROPERLY AND FULLY uploaded onto Caselines to enable the Judge to read the papers.
