JUDGE'S DIRECTIVES

DIRECTIVES:

1. Applicants in all matters are directed to ensure that a paginated bundle is available on Case Lines containing all documents filed of record (including an <u>updated</u> practice note) in the matter by no later than 15h00 on the 26 of August 2025 and to check that the secretary to Weideman AJ and all the parties' representatives are "invited" to the electronic court file on Case Lines, failing which the matter is not likely to be dealt with.

- 2. Representatives must ensure that the files on Case Lines comply with paragraph 7 and paragraph 27 of the Revised Consolidated Practice Directive 1 of 2024 (revised 12 June 2024). Litigants are requested to take note of the guidelines set out in the Mediation Protocol for the Gauteng Division (June 2025) especially paragraph 4.9 thereof.
- 3. There are 183 applications set down for hearing from 25 August 2025 to 28 August 2025. Time will not allow for indulgences or standing down of matters in order for non-compliance to be remedied.
- 4. All the documents that the presiding judge are required to read must be uploaded and listed under one single Case Lines section with the clearly marked heading as follows: "Special Interlocutory Application". Create clearly marked sub-sections within the section please refrain from uploading all the various notices, draft orders, practice note and other documentation as a single bundle.
- 5. Failure to comply with the directives set out here above will, save in exceptional circumstances, result in the removal of non-compliant matters from the court roll.
- 6. It is the responsibility of practitioners to ensure that their draft orders are in the correct format. Please ensure that the name of the presiding judge is reflected on the order and that the case number and link number (in the event of an RAF matter) are correct.
- 7. Applicants must have 1 hard copy of their proposed draft order available for the presiding judge to sign in court.
- 8. The court session will start at 10h00 with postponements and removals. Thereafter, legal representatives will be heard in order of seniority.
- 9. Legal representatives are excused from introducing themselves to Weideman AJ in chambers from 25 August 2025 to 28 August 2025
