- 1. The unopposed motions before Yacoob J will be heard physically in open court.
- 2. Court will start at 10:00, starting with removals and postponements.
- 3. Practitioners may introduce themselves to the Judge in chamber 1002 at 09h45.
- Counsel will be heard in order of seniority.
- 5. Parties must ensure that the files on CaseLines comply with paragraphs 7, 24 and 26 of the Revised Consolidated Practice Directive 1/2024 and any other paragraphs that may be relevant to that particular matter, by 16h00 on Friday 10 October 2025, failing which the matter is at risk of not being dealt with.
- 6. Should any of the parties have any doubts about the correct directive, please contact Ms Moropa through her email.
- 7. A compliant Practice Note relevant to this hearing, and properly labelled, must be uploaded by no later than **16h00 on Friday 10 October 2025**.

- Draft Orders (TO BE HEADED: COURT ORDER/ ORDER), are to be uploaded in Word format. The matter number on the roll, the date of hearing, the Judge's name (YACOOB J) must be populated in the Draft Order.
