- 3. Practitioners may introduce themselves to the Judge in chamber 1002 at 09h45.
- 4. Counsel will be heard in order of seniority.
- 5. Parties must ensure that the files on CaseLines comply with paragraphs 7, 24 and 26 of the Revised Consolidated Practice Directive 1/2024 and any other paragraphs that may be relevant to that particular matter, by 09h00 on Tuesday 14 October 2025, failing which the matter is at risk of not being dealt with.
- 6. Should any of the parties have any doubts about the correct directive, please contact Ms Moropa through her email.
- 7. A compliant Practice Note relevant to this hearing, and properly labelled, must be uploaded by no later than **09h00 on Tuesday 14 October 2025**.

- Draft Orders (TO BE HEADED: COURT ORDER/ ORDER), are to be uploaded in Word format. The matter number on the roll, the date of hearing, the Judge's name (YACOOB J) must be populated in the Draft Order.
- 9. In addition to uploading, practitioners are to present <u>one</u> hard copy of the Draft Order when their matters are called. A Word version of the Draft Order should also be emailed to the Judge's secretary MMoropa@judiciary.org.za.
- 10. Notice of Removals should be emailed to MMoropa@judiciary.org.za for matters that are to be removed by notice, as soon as possible (in addition to uploading).
- 11. All correspondences & communication is to be limited to the above email address.
- 12. Please advise Ms Moropa as soon as possible on the above email address if, for any reason, the judge should not read the papers in the matter.
- 13. Litigants with matters not yet bundled to CaseLines are to ensure that their matters are bundled and migrated to CaseLines by no later than 09h00 on Tuesday 14 October 2025 and to advise via email once migration has been done.
