DIRECTIVES IN RESPECT OF UNOPPOSED MOTIONS BEFORE THE HONOURABLE JUDGE KHABA AJ

- 1. The unopposed motions before Judge Khaba AJ will be heard physically in open Court.
- 2. Court will start at 10:00, starting with removals and postponements.
- 3. Practitioners may introduce themselves to the Judge in chamber 1006 at 09h45.
- 4. Counsel will be heard in order of seniority.

- 5. If matters are not visible on CaseLines and the bundles are not reflecting in order as to the sections on Court Online, such matters will be removed from the roll. The matters highlighted in red indicate those were papers are not visible. All papers must be uploaded and visible on Caselines by Monday 20 October 2025 at 15h00pm.
- 6. Parties must ensure that the files on CaseLines comply with paragraphs 7, 24 and 26 of the Revised Consolidated Practice Directive 1/2024 and any other paragraphs that may be relevant to that particular matter.
- 7. All matters documents to be placed before the Court, including practice notes and draft orders, must be uploaded on Caselines by no later than 15h00pm on Monday the 20th of October 2025, failing which the matter may be removed from the roll. Documents uploaded outside the stipulated time will not be considered and will result in the matter being removed from the roll.
- 8. A compliant Practice Note relevant to this hearing, and properly labelled, must be uploaded by no later than Monday on 20 October 2025.

- 11. Notice of removals should be emailed to NMakgalefa@judiciary.org.za for matters that are to be removed by notice, as soon as possible (in addition to uploading).
- 12. All correspondence & communication is to be limited to the above email address.
- 13. Please advise Ms Makgalefa as soon as possible on the above email address if, for any reason, the judge should not read the papers in the matter.
