Parties must ensure that the files on CaseLines comply with paragraphs 7, 24 and 26 of the Revised Consolidated Practice Directive 1/2024 and any other paragraphs that may be relevant to that particular matter, by 16h00 on 17 OCTOBER 2025, failing which the matter is at risk of not being dealt with.

- 7. A compliant Practice Note relevant to this hearing, and properly labelled, must be uploaded by no later than **16h00 on 17** OCTOBER 2025.

- 10. Notice of Removals should be emailed to BTlhowe@judiciary.org.za for matters that are to be removed by notice, as soon as possible (in addition to uploading).

- 12. Please advise Ms Tlhowe as soon as possible on the above email address if, for any reason, the judge should not read the papers in the matter.
