PLEASE TAKE NOTE OF THE FOLLOWING DIRECTIVES:

1. The hearing of all unopposed divorces will be heard in open Court, commencing at 10:00.
2. Introductions will be done in open Court.
3. Documents must be uploaded in all matters to CaseLines by no later than noon on 02 December 2025. All non-compliant unopposed Divorces shall automatically be removed from the roll. The relevant documents to be uploaded include:

- (3.1). A practice note containing reference to submissions, if any, by Counsel for the Party and a request, if any, to make oral submissions.
- (3.2) Practice notes and draft orders sent by email will not be accepted. They must be accessible on CaseLines and uploaded within the stipulated timeframe.
- (3.3) An affidavit from the Plaintiff containing the relevant evidence, which must address in detail the arrangements contemplated for the minor children and the views or endorsement of the Family Advocate, if any
- (3.4) Certified copies of the marriage certificate and the settlement agreement, if any.
- (3.5) The draft order should set out the date of the hearing, number on roll, must be populated in the Draft Order and the name of Counsel appearing with his/her full contact details and those of the instructing Attorney should appear at the end of the draft order to which a copy of the settlement agreement, if any is attached.
- 4. One hard copy of the draft order and the settlement agreement (if applicable) must be brought to Court on 05 December 2025 to be handed up should the Order so sought be granted.
- 5. All unopposed divorces must be dealt with by adducing evidence on affidavit and no party shall testify in person, save where the Judge orders otherwise by way of a Widely Shared Case Note.
- 6. Counsel and Attorneys are required to check for any Notes concerning their matters on CaseLines prior to attending Court on Friday, 05 December 2025.
